**Subject : Deduction of tax at source on dividend under relevant sections of the Income- tax Act, 1961 - Final Equity Dividend 2020-21**

First and foremost, we wish you and your family good health and hope you are safe and fine.

We are glad to inform you that the Board of Directors at its meeting held on April 29, 2021 has recommended a Final Equity Dividend of ₹ 6 per Equity Share of face value of ₹10/- each for the Financial Year ('FY') ended March 31, 2021.

The register of Members of the Company would remain closed from Friday, June 18, 2021 till Thursday, June 24, 2021.

The Final Equity dividend will be paid(subject to the approval of shareholders at the 42nd Annual General Meeting to be held on Thursday, June 24, 2021) to those members whose names appear:

- a. As members on the Register of Members of the Company as on Thursday, June 17, 2021 after giving effect to all valid transmission or transposition requests lodged with the Company for the shares held in physical form up to the closing hours of business on Thursday, June 17, 2021.
- b. As beneficial owners as per the list to be furnished by NSDL/ CDSL as at the closing hours of business on Thursday, June 17, 2021.

As you may be aware, as per the Income-tax Act, 1961 ('the Act'), dividends declared or distributed or paid by a Company during the Financial year 2021-22 shall be taxable in the hands of the Shareholders and the Company shall be required to deduct tax at source ('TDS') at the prescribed rates from the dividend to be paid to shareholders at the time of distribution or payment of dividend. The tax so deducted will be paid to the credit of the Central Government.

The TDS rate would vary depending on the residential status of the Shareholder and the documents submitted by them and accepted by the Company in accordance with the applicable provisions of the Act. Accordingly, the Final Equity Dividend will be paid on or after July 7, 2021 deducting TDS as explained herein.

**Notes:**

1. In due compliance of the applicable provisions of the Act, the Company will be issuing certificate for TDS in Form 16A. The credit of TDS can also be verified by the Shareholder by verifying Form 26AS, after the statement of TDS is furnished by the Company and thereafter Annual Information Statement (Form 26AS) is updated.
2. All the above referred tax rates will be enhanced by surcharge and cess, as applicable.
3. For all self-attested documents, shareholders must mention on the document “certified true copy of the original”. For all documents being uploaded by the shareholder, the shareholder undertakes to send the original document(s) on request by the Company.
4. In case the aggregate of dividend payout of 2nd interim dividend 2020-21 paid on April 16, 2021 and other dividends paid during Financial year 2021-22 [interim, final or by any other name called] exceeds Rs. 5,000 for an individual shareholder, TDS will be calculated on the aggregate amount and deducted from the next sequential dividend paid upto 31 March 2022.
5. Shareholders holding shares under multiple accounts under different status/ category and single PAN, may note that, higher of the tax as applicable to the status in which shares are held under a PAN will be considered on their entire holding in different accounts.
6. Needless to mention, PAN will be mandatorily required. In absence of PAN/ valid PAN, tax will be deducted at a higher rate of 20% as per section 206AA of the Act.
7. In case, dividend income is assessable to tax in the hands of a person other than the registered Shareholder as on the Record Date, the registered shareholder is required to furnish a declaration containing the name, address, PAN of the person to whom TDS credit is to be given and reasons for giving credit to such person.
8. Above communication on TDS sets out the provisions of law in a summary manner only and does not purport to be a complete analysis or listing of all potential tax consequences. Shareholders should consult with their own tax advisors for the tax provisions that may be applicable to them.
9. We shall arrange to email the soft copy of the TDS certificate at your registered email id in due course, post payment of dividend.

10. In case tax on dividend is deducted at a higher rate in the absence of receipt of the aforementioned details/ documents, the concerned Shareholder would still have the option of claiming refund of the excess tax deducted at the time of filing the income tax return. No claim shall lie against the Company for such taxes deducted.

11. In the event of any income tax demand (including interest, penalty, etc.) arising from any misrepresentation, inaccuracy or omission of information provided/ to be provided by the Shareholder(s), such Shareholder(s) will be responsible to indemnify the Company and also, provide the Company with all information/ documents and co-operation in any appellate proceedings.

12. As per present requirement; PAN and Aadhar number have to be linked upto 30th June 2021. Non-linking will render PAN as invalid and higher TDS would be applied in such a case.

13. Higher TDS in case of person not filing of Income Tax Return.

- Section 206AB has been introduced by the Finance Act, 2021, whereby TDS will be higher of the following:
- Twice the rate specified in the relevant provision of the Income-tax Act; or
- Twice the rate or rates in force; or
- the rate of five per cent;

In case a person has not filed his/her Return of Income for each of the two preceding financial years and the aggregate of tax deducted at source in his/her case is ₹50,000 or more in each of these two financial years. These provisions will be effective from 1st July, 2021.

These documents, valid in all respects, should be submitted on or before June 17, 2021 in order to enable the Company to determine and deduct appropriate TDS/ withholding tax rate. No communication on the tax determination/ deduction shall be entertained post June 17, 2021. Decision of the Company with respect to the validity of any document will be final.

Shareholders are requested to update their bank account in their Demat accounts / Folio, by contacting the DP or RTA of the Company. Your co-operation in this regard is solicited.
